



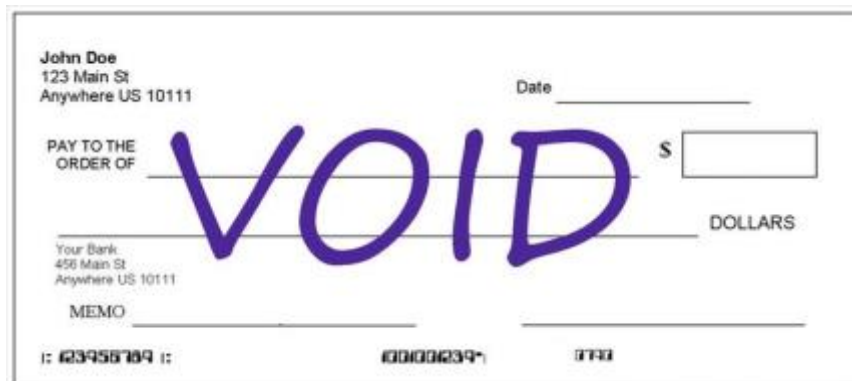

WHAT IS THE PRE-AUTHORIZED GIVING PLAN?

The Archdiocese of Toronto has established a Pre-Authorized Giving Plan to assist you in your support of the work of St. Pius X Catholic Church through your regular parish offerings (**This does not include special collections**).

The work of our parish is made possible through the generosity of our parishioners. In response to changing lifestyles and demands on time and energy, the Archdiocese of Toronto seeks, through pre-authorized giving, to assist you in your giving.

Pre-Authorized Giving may be a good choice for you.

Pre-authorized Giving creates a win/win situation for you and St. Pius X Catholic Church. It's a very simple procedure. When you participate in Pre-Authorized Giving, your offering will be withdrawn from your account on the 20th day of the month. This amount will then be deposited to the parish's account.

Tax receipts will be issued at the end of the year by the Parish Office.

WOULD YOU BE WILLING TO SUPPORT THE MISSION OF THE PARISH?

Advantages for the donor:

- Convenience – Reduces the need for envelopes each week.
- Security – A secure e-transfer from your account to the Church's account.
- Enables better planning of Parish activities for the future.

Advantages for the Parish:

- Regular, dependable flow of contributions to the parish. (Donations dip dramatically during the summer and when people are away for work or holidays)
- Reduction of paperwork and bookkeeping.

How to enroll?

- Decide the amount of your gift to St. Pius X Catholic Church to be withdrawn from your account each month.
- Fill out the form and attach a cheque from your account marked "VOID".
- Put the form and void cheque in a sealed envelope, and place it in the collection basket OR mail to the Parish Office, Attn: Parish Coordinator.

Who Looks after the plan?

The Office of Stewardship and Development of the Archdiocese of Toronto administers the Pre-Authorized Giving Plan for the parish. Please note that our Parish Office will issue a tax receipt for all offertory gifts.

CALCULATING THE MONTHLY PRE-AUTHORIZED GIVING

To help determine the amount of one's monthly deduction, the following calculation is presented as an example and guide.

Please note the Special Diocesan Collections throughout the year like Shepherd's Trust, Mission Appeal, World Mission Sunday etc., have not been included in the calculation given below:

Offertory - \$40 X 12 mos. = \$480

Building Fund \$10 X 12 mos. = \$120

ShareLife - \$120/yr. = \$120

Total Contribution for the year = \$720

To calculate the monthly Pre-Authorized Giving (PAG), divide your yearly contribution, i.e. \$720 by 12 months.

= \$60 per month
